We demonstrate near school properties but do not go onto school grounds. We support the efforts of other groups advocating for change in the policy and integration of appropriate books for minors. We also support efforts to strengthen the security at all schools. We do not support trespassing, distributing materials with sexual content, or confrontation with parents or school staff. N.C.G.S. §14-190.7. Dissemination to minors under the age of 16 years.

Every person 18 years of age or older who knowingly disseminates to any minor under the age of 16 years any material which he knows or reasonably should know to be obscene within the meaning of G.S. 14-190.1 shall be guilty of a Class I felony.

Elements

A person guilty of this offense

(1)is 18 years of age or older and

(2)knowingly

(3)disseminates

(4)to a minor under the age of 16 years

(5)obscene material

(6)that the person knows or reasonably should know

(7)is obscene.

Obscenity is judged with reference to ordinary adults, except that it is judged with reference to children or other especially susceptible audiences if its dissemination is designed for or directed toward children or such audiences. G.S. 14-190.1(d).

Punishment

Class I felony. G.S. 14-190.7

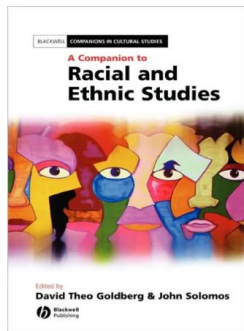

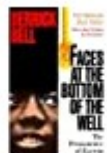

Critical Race Theory material. Kendi's core thesis — that racism is the single, self-evident cause of racial differences in everything from school grades to incarceration rates to income and thus must be rectified using “antiracist discrimination”

“When I see racial disparities, I see racism,” Kendi says, to the exclusion of other explanations.

Kendi's actual policy proposals, from “defunding the police” to restricting free speech, are much more alarming than his fraudulent posturing. Kendi is an open advocate for race-based discrimination, arguing that “the only remedy to past discrimination is present discrimination.” Even worse, he has proposed a federal “Department of Antiracism,” unaccountable to voters or legislators, with the power to suppress “racist ideas” and veto, nullify or abolish any law at any level of government not deemed “antiracist” — a policy that verges on the totalitarian.

Fortunately, as Americans have begun to seriously consider his ideas, Kendi finds himself on the defensive. In recent months, he has released a series of touchy and short-tempered articles and statements, claiming that “there is no debate about critical race theory” in one moment, then distancing himself from CRT in the next — despite the fact that only two weeks earlier, he had claimed that critical race theory was “foundational” to his work.

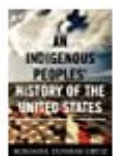

Derrick Albert Bell Jr. was an American lawyer, professor, and civil rights activist. In 1971, he became the first tenured African-American professor of law at Harvard Law School, and he is often credited as one of the originators of critical race theory along with Richard Delgado, Charles Lawrence, Mari Matsuda, and Patricia Williams. His often contrarian views and the challenges he posed to liberal notions of social justice made him a foundational figure in what became critical race theory. Critical race theory (CRT) as a school of legal thought grew out of critical legal studies (CLS), a movement examining how the legal system, rather than acting as an impartial arbiter of justice, served to uphold existing power structures. Bell's thinking and writing heavily influenced critical race theorists, like Richard Delgado and Jean Stefancic, when it came to tackling similar topics from the perspective of race and racial inequality.

Bell's own advocacy experience, as well as his observations of the ways civil rights cases worked out in practice—especially affirmative action and school desegregation cases—made him pessimistic about whether American society could ever achieve racial equality. Dovetailing with the ideas circulating in CLS groups, Bell believed in the permanence of racism and the persistence of white supremacy, due primarily to what he referred to as the interest-convergence dilemma. Through the interest-convergence dilemma, Bell posited that racial progress for nonwhite people in the United States was only possible if the goals of the racial justice movement were the same as those of the white-dominated power structure.

Anderson said he is seeking "a restraining order against Barnes and Noble and Virginia Beach Schools to enjoin them from selling or loaning these books to minors without parent consent." The books in question are "Gender Queer," a memoir by Maia Kobabe; and "A Court of Mist and Fury," a fantasy novel by Sarah J. Maas. "There is probable cause to believe that the book 'A Court of Mist and Fury' is obscene for unrestricted viewing by minors," according to the request for a restraining order.

They always say a book aimed at young people should start with a bang. How about this one? " 'OK,' said Jonathon. 'The choice is this. You either have to shag Jenny Gibson or that homeless woman who begs spare change outside Cramner's bakers.' "

Just a shock to draw you in, you think, till the conversation unfolds: "'I'd take the homeless. She wouldn't be so bad once you'd cleaned her up.'

'You have to take her as is.'

'Can I shag her from behind?'

'No, from the front. With the lights on. Snogging and everything. And you have to do oral sex on her too ... Oral sex until she comes.'"

On it goes, comparing the turn-offs of poor Jenny, "the ugliest girl in college", and the tramp with "rotten teeth and smelly breath, bits of old kebab rotting in her teeth. Cold sores, probably. Ulcers." Perhaps it gets better, you think. Well, perhaps it does, if you think "the gentle hiss of a roomful of drenching gussets", or a girl "with her knickers hardly covering her bush", or "I slid my hand down her arse and tickled her crack" are improvements.

No. It gets worse, right down to the touching prayer, "Please, please make Deborah thin - but with big tits so I'd still have those wonderful bazookas to play with." And the sensitive observation that "tits and minge are actually very important things to me in a girlfriend. I spend a lot of time looking at them on my computer screen - tits and minge and arse till it comes out of my ears."

(A bit of a thing is made about arses, in this book. I should stop. Spare you the counting of the number of fingers a boy managed to fit up inside his girl, a lad's heavy petting before coming back to "make us all sniff his fingers to show he'd been there". The charming exchanges of courtship: "'Feel yer tits?' 'No.' 'Bit of finger?' 'No!'

"And, of course, Dino's discovery of his first girl's bottom: "It had this amazing spicy, pee-y smell."

The strapline across the bound proofs in front of me claim this book (to be published in May) is Melvin Burgess's "latest assault on teenage morals". The Observer's quite wrong there. Young girls will be begging their parents to send them to single sex schools. Reading this will put many off dating for years.

What are three separate children's publishers thinking of, peddling this grubby book, which demeans both young women and young men? It will prove as effective a form of sexual bullying as any hardcore porno mag passed round. And, make no mistake, the publishers may slap a warning and a picture of a condom on the front and substitute a grown-up penguin for a puffin, but it was the children's publisher Andersen Press that commissioned this novel. It is Random House Children's Books who have it in their catalogue beside Emma Chichester Clark's Up in Heaven and Ken Brown's What's the Time, Grandma Wolf? (ages 4 and up). And the people who are putting most into this book are Penguin Children's Books, who were thrilled to win the paperback auction.

Summary- *** The following version of this book was used to create this study guide: Stone, Nic. *Odd One Out*. New York: Crown, 2018. The novel is broken into three parts - or books - told entirely from one of the three main characters - first Courtney, then Rae, then Jupiter. Each book contains ten chapters. For the purposes of this guide, each book is separated into two sections. Book One, *The Game Plan*, is told from Courtney Coopers (Coops) first person perspective. It starts with Coop explaining his recent break up, and how he goes to Jupe's house for the Jam, the song she plays for him when he breaks up with someone. He explains how he has been in love with Jupe since he and his Mom moved next door as a kid. However, Jupiter is gay and does not seem romantically interested. So they are just best friends who hang out and sleep together platonically. He tells his friends Golly and Britain about his break up but they tell him he needs a game plan to get over Jupe and to start dating a new girl. He spends time apart from Jupe, but starts having nightmares. He also notices her friend Breanna at her house which makes him jealous. That weekend his Mom has a party and invites a new family in town - Dr. Chin and his daughter Rae. Jupe and Rae are already close and Coop is jealous. Coop invites Rae to try out for the cheerleading team, as she is talented, and accepted immediately. After practice one day they all attend a carnival together, but at the carnival Coop passes out. Afterwards, Rae helps him recover and they realize they have a lot in common - Coop lost his Dad as a kid and Rae's Mom moved out. They also realize they both went to the Carl's Carnival event in Alabama when they were kids and decide to find Carl together. Rae and Coop start to grow close. However, Rae and Jupe are also close and flirty with each other. Meanwhile, Coop feels confused about Jupe since she flirts with him - even sometimes checking him out but claims she has a crush on a girl. Rae calls Coop in the middle of the night to console her while her father is away and Coop likes to feel needed. Book One, and Coops perspective ends as he thinks he has a crush on Rae. Book Two, *A Sesquipedalian Search for a Simplified-Science Savant* is told from Rae's perspective (103). Rae wakes up in Courtney's house feeling embarrassed. Thanksgiving night Rae drinks too much and asks Jupe if she can kiss her but Jupe says no. The football season ends and they party together, while Rae still feels like an outsider but loves being around Jupiter and Courtney. Rae and Courtney go on a Carl finding excursion together, and Courtney warns Rae not to try to hook up with Jupiter, and reminds her about Thanksgiving night, which Rae had been too drunk to remember. They visit Carl's abandoned home, and find their family pictures inside. This reminds Rae of the past and how she misses her sister, and how she always feels left behind. Christmas comes and all three families celebrate together at Jupiter's house. When Rae comes home she finds her sister Bess waiting for her. At first she is angry, but Bess explains how their Mom needed her, and their Dad had persuaded Bess to go. On New Years Eve, Jupiter insists Rae's attempt to kiss her was a drunken mistake, and Rae kisses her to prove it was not which angers Jupiter. They stay friends but it feels fake, and Rae grows closer to Courtney. Courtney also finds Carousel Carl - he has started Carl's Closet - a secondhand clothing non-profit and Rae is pleased. Later, Bess tells Rae that Jupiter is in love with Rae, and she should tell Jupiter the truth. Then, Jupiter tells Rae they need to talk, but Rae cuts her off and tells Jupiter that she is in love with Courtney and going to tell him after his birthday. Book Two ends as she and Jupiter hug. Book Three, *Another One Bites the Dust* is told from Jupe's perspective (195). It begins as Jupe leaves Rae's house upset that she was about to tell Rae she loved her, but Rae told her she is in love with Courtney. Jupe resolves that since she is about to lose both Rae and Courtney, to sleep with Courtney first, so they can be each others firsts. A week later they have sex and they tell each other they love each other. Jupe gives Coop her bracelet as his 18th birthday present. Soon after, Rae calls Coop to ask him out. Coop asks Jupe what to do and Jupe tells him to go for it, and they fight. Coop realizes that Jupe knew Rae's plan all along and is angry. He starts dating Rae and Jupe is jealous. Jupe goes out with Breanna and has sex with her. She enjoys it, but feels confused about her identity and label. Her relationship with Rae and Coop grows frosty. Jupe finally asks for help from Britain and Golly, who help her make and execute a game plan. She confesses to her LGBT group including Coop and Rae, that she likes boys too, but she does not know her label. Later, Jupe confesses to Rae that she slept with Coop and why. A few days later Coop, Golly, and Britain come over and bring her birthday present - a turntable and Queen records Coop got from Carl. Coop brings a letter from Rae in which she both forgives Jupe and asks for forgiveness. Coop then tells Jupe to cue the Jam - he and Rae are broken up. Jupe tells him she is not ready for a relationship yet, but they tell each other they love each other, and the novel ends as Jupe hits play.

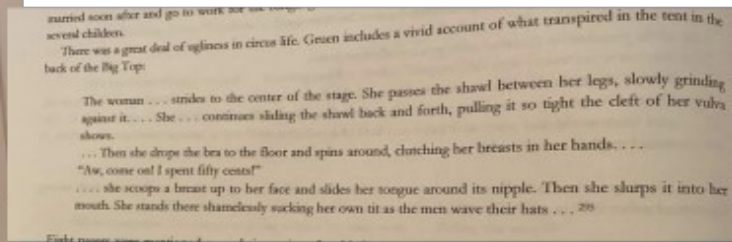
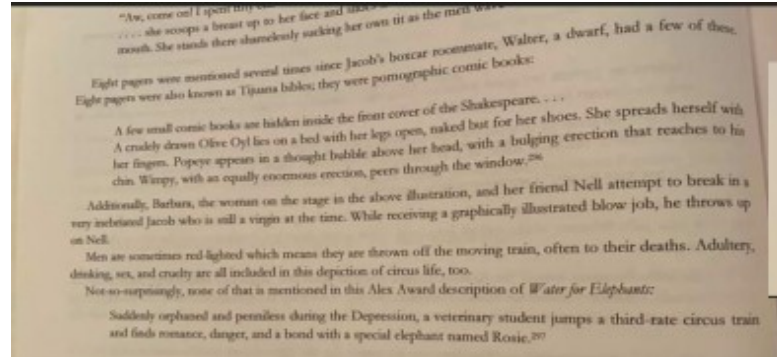

In the summer of 1987, 15-year-old Aristotle Mendoza meets a boy named Dante Quintana at the local pool. The boys bond over their classical names and eventually become inseparable. Dante teaches Ari about literature and poetry, while Ari is fascinated by Dante's swimming ability and sincerity.

Dante tells Ari that he and his family are moving to Chicago for the next school term because his father was offered a temporary professorship at the University of Chicago. That same day, the two boys see a bird lying injured in the road. While Dante goes into the road to check on the bird, a car speeds around the corner. Ari dives into the street and pushes Dante out of its path, saving his life. While Dante leaves almost unscathed, Ari is hurt very badly. Following the accident, the Quintanas and the Mendozas grow closer. Both boys' mothers talk more frequently and share ideas about their sons.

Before Dante leaves for Chicago, he tells Ari that the two things he loves most in the world are swimming and Ari. However, Ari says that he should not tell him those things, even if they are true. The two boys promise each other that they will still be friends when Dante returns in the summer.

Over the next year, Dante sends Ari several letters detailing his life in Chicago and struggling with his sexuality. Ari learns to drive, falls in love with a girl from school, and searches for answers to his questions about his brother Bernardo, who is in prison for reasons no one in his family will discuss.

The next summer, Dante convinces Ari to kiss him as an experiment. It becomes increasingly clear that Dante is in love with Ari, who appears not to reciprocate Dante's feelings for him.

Ari's father announces that his Aunt Ophelia had had a fatal stroke. At the funeral, Ari realizes that none of his extended family is there. He is told that they disapproved of Aunt Ophelia having lived with another woman for many years. After the funeral, Ari's mother explains that Ari's brother, Bernardo, was arrested for the murder of a prostitute he hired when he was 15 years old. When Bernardo found out the prostitute was transgender, he killed her with his bare fists.

When Ari returns home, Mr. Quintana tells him that Dante is in the hospital. He was jumped by several young men who had seen him kissing his boyfriend Daniel in an alley. Ari tracks down Julian, one of the boys who attacked Dante, at the body shop where he works and starts a fight with him. Mr. Quintana asks if Ari knows why Dante was jumped. Ari tells him that Dante is gay and was kissing another boy. Mr. Quintana admits that he'd guessed the truth because of the way Dante looks at Ari, while Mrs. Quintana tells Ari she thinks Dante is in love with him and that Daniel is just a stand-in for Ari.

Ari's mother eventually calls a family meeting, where Ari finally accepts that he is as much in love with Dante as Dante is with him. That night, the two families go bowling together. After bowling, Dante and Ari go out into the desert, where Ari kisses Dante, fully accepting his love for him. Now free of his fears, Ari is left wondering: "How could I have ever been ashamed of loving Dante Quintana?"

THIS, for high school students? I am intentionally not including an explicit scene including the character Robert and the "gray suit" stroking his penis.

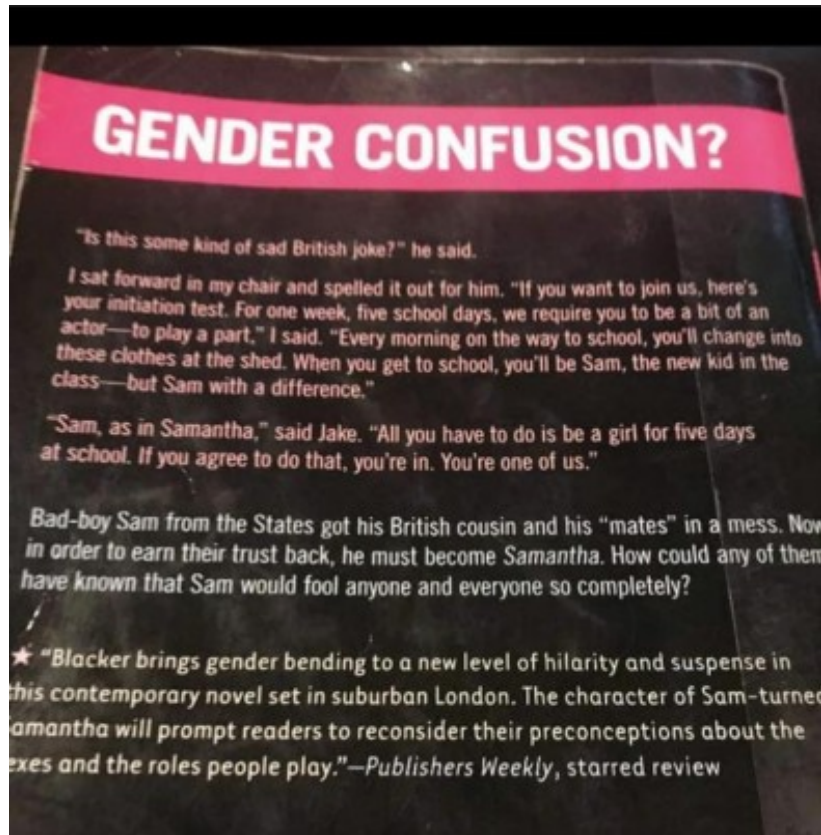

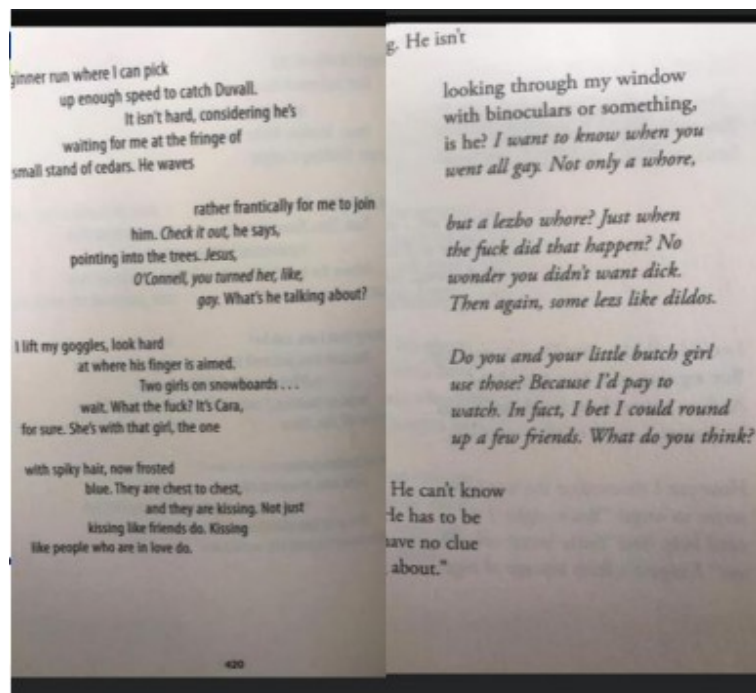

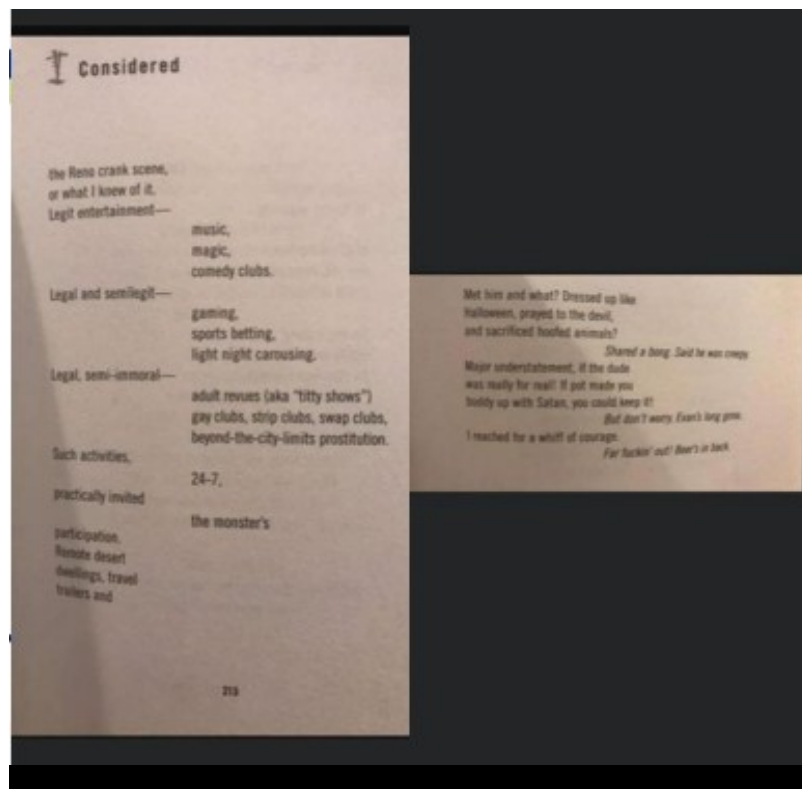

In *The Bluest Eye*, sex is associated with violence, humiliation, and immorality. Instead of sex being an enjoyable act between two people, sex, like race and beauty standards, works as a form of oppression. For both men and women, sexual initiation has devastating effects on an individual's life and sense of self. The scenes of sexual initiation are particularly violent and humiliating, leaving a lasting effect on the novel's characters.

Cholly's first sexual experience is paired with humiliation and hatred, as the white men force him to rape Darlene. Frieda's first sexual experience is forced upon her by Mr. Henry, and causes her to believe she has been ruined. And Pecola's sexual initiation happens through rape.

Men in the story use sex as a means to oppress the women in their lives. Their sexual desires are distorted by their past sexual failures and their ideas concerning the value of women. Cholly's first sexual experience leads to his hatred of women, hatred of his own race, and his feeling of being unlovable. The combination of these things leads to the rape of his daughter. Soaphead Church's failed marriage and hatred of women leads to the direction of his repressed sexual desire toward children.

For the younger characters in *The Bluest Eye*, sex becomes the defining element of their passage into womanhood. The adolescent girls in the story, however, lack a true understanding of the perilous nature of sex. They hold idealistic views of what sex means, associating sex with love and a sense of self worth as a woman.

The primary thematic elements of Deogratias concern what human beings are capable of becoming. While the flashbacks in the narrative develop a fairly familiar coming-of-age story, this bildungsroman is disrupted by the genocide and Deogratias's complicity in it. During his development into an adult, Deogratias is concerned with girls and drinking, making him quite recognizable to the average Western reader. However, at the cusp of his adulthood, rather than becoming a man, he becomes a dog; his involvement in the genocide, in terms of both what he has witnessed and what he has done, damage his self-image. This is important not only in its subversion of the coming-of-age narrative but also in its allusion to Art Spiegelman's Maus: A Survivor's Tale (1972-1991) and other graphic novels in which human characters are depicted as animals. Deogratias modifies this familiar trope, however, by depicting a physical transformation that takes place during the incursion of traumatic memories—that is, Deogratias becomes a dog only when he cannot find enough alcohol to dull his senses.

§14-190.1. Obscene literature and exhibitions.

(a) It shall be unlawful for any person, firm or corporation to intentionally disseminate obscenity. A person, firm or corporation disseminates obscenity within the meaning of this Article if he or it:

- (1) Sells, delivers or provides or offers or agrees to sell, deliver or provide any obscene writing, picture, record or other representation or embodiment of the obscene; or
- (2) Presents or directs an obscene play, dance or other performance or participates directly in that portion thereof which makes it obscene; or
- (3) Publishes, exhibits or otherwise makes available anything obscene; or
- (4) Exhibits, presents, rents, sells, delivers or provides; or offers or agrees to exhibit, present, rent or to provide: any obscene still or motion picture, film, filmstrip, or projection slide, or sound recording, sound tape, or sound track, or any matter or material of whatever form which is a representation, embodiment, performance, or publication of the obscene.

(b) For purposes of this Article any material is obscene if:

- (1) The material depicts or describes in a patently offensive way sexual conduct specifically defined by subsection (c) of this section; and
- (2) The average person applying contemporary community standards relating to the depiction or description of sexual matters would find that the material taken as a whole appeals to the prurient interest in sex; and
- (3) The material lacks serious literary, artistic, political, or scientific value; and
- (4) The material as used is not protected or privileged under the Constitution of the United States or the Constitution of North Carolina.

(c) As used in this Article, "sexual conduct" means:

- (1) Vaginal, anal, or oral intercourse, whether actual or simulated, normal or perverted; or
- (2) Masturbation, excretory functions, or lewd exhibition of uncovered genitals; or
- (3) An act or condition that depicts torture, physical restraint by being fettered or bound, or flagellation of or by a nude person or a person clad in undergarments or in revealing or bizarre costume.

(d) Obscenity shall be judged with reference to ordinary adults except that it shall be judged with reference to children or other especially susceptible audiences if it appears from the character of the material or the circumstances of its dissemination to be especially designed for or directed to such children or audiences.

(e) It shall be unlawful for any person, firm or corporation to knowingly and intentionally create, buy, procure or possess obscene material with the purpose and intent of disseminating it unlawfully.

(f) It shall be unlawful for a person, firm or corporation to advertise or otherwise promote the sale of material represented or held out by said person, firm or corporation as obscene.

(g) Violation of this section is a Class I felony.

(h) Obscene material disseminated, procured, or promoted in violation of this section is contraband.

(i) Nothing in this section shall be deemed to preempt local government regulation of the location or operation of sexually oriented businesses to the extent consistent with the constitutional protection afforded free speech.

Elements

A person guilty of this offense

- (1)intentionally
- (2)disseminates
- (3)obscenity.

Punishment

Class I felony. G.S. 14-190.1(g).

Notes

Generally. The statute applies to any person, firm, or corporation that does the prohibited acts. G.S. 14-190.1(a). The statutory language regarding corporations appears to be unnecessary given that the term “person” as used in the General Statutes always is interpreted to include corporations. See “ ‘Person’ includes corporation” in the Introduction to this book.

Element (1). See “Intentionally” in Chapter 1 (States of Mind). The defendant must know the character or content of the material or performance disseminated. *Smith v. California*, 361 U.S. 147 (1959); *State v. Anderson*, 322 N.C. 22 (1988); *State v. Watson*, 88 N.C. App. 624 (1988); *State v. Von Wilds*, 88 N.C. App. 69 (1987); *State v. Smith*, 87 N.C. App. 217 (1987); *Cinema I Video, Inc. v. Thornburg*, 83 N.C. App. 544 (1986).

Element (2). Dissemination occurs if the defendant:

sells, delivers, provides, or offers, or agrees to sell, deliver, or provide, any obscene writing, picture, record, or other representation or embodiment of the obscene;
presents or directs an obscene performance or participates directly in the portion of the performance that makes it obscene;
publishes, exhibits, or makes available anything obscene; or
exhibits, presents, rents, sells, delivers, provides, or offers or agrees to exhibit, present, rent, or provide, any obscene still or motion picture, film, filmstrip, projection slide, sound recording, sound tape, sound track, or any matter or material of whatever form which is a representation, embodiment, performance, or publication of the obscene.

G.S. 14-190.1(a)(1)–(4).

Element (3). The product of dissemination can be either material or a performance. G.S. 14-190.1(a).

Under G.S. 14-190.1(b), material is obscene if all four of the following criteria apply:

1. The material depicts or describes sexual conduct in a patently offensive way. No matter how offensive the material may be, unless it involves sexual conduct, it is not obscene. "Sexual conduct" includes:

vaginal, anal, or oral intercourse, actual or simulated, normal or perverted;
masturbation, excretory functions, or lewd exhibition of uncovered genitals (although "simulated" is not repeated here, the statutory definition of obscene material covers material that "depicts or describes" sexual conduct); and
an act or condition that depicts torture, physical restraint by being fettered or bound, or flagellation of or by a nude person or a person clad in undergarments or in revealing or bizarre costume.

G.S. 14-190.1(c).

Whether the material is patently offensive is a jury question and is to be judged by contemporary community standards. *State v. Anderson*, 322 N.C. 22 (1988); *State v. Watson*, 88 N.C. App. 624 (1988). The statute does not specify the geographical limits of the relevant community; a trial judge may permit jurors to apply the standards of their local communities. *State v. Mayes*, 323 N.C. 159 (1988); *Anderson*, 322 N.C. 22.

2. The average person applying contemporary community standards relating to the depiction or description of sexual matters would find that the material taken as a whole appeals to the prurient interest in sex. In making this determination, a trial judge may permit jurors to apply the standards of their local communities. *Mayes*, 323 N.C. 159, *Anderson*, 322 N.C. 22. The State is not required to present evidence of what constitutes contemporary community standards. *State v. Johnston*, 123 N.C. App. 292 (1996). A "prurient" interest in sex means a shameful or morbid interest, as opposed to a normal, healthy interest. *Brockett v. Spokane Arcades, Inc.*, 472 U.S. 491 (1985); *Johnston*, 123 N.C. App. 292.

3. The material lacks serious literary, artistic, political, or scientific value. The value of material must be decided with reference to the work as a whole. *Miller v. California*, 413 U.S. 15 (1973); *State v. Smith*, 89 N.C. App. 19 (1988); *Watson*, 88 N.C. App. 624. Also, in contrast to the criteria of patent offensiveness and appeal to the prurient interest in sex discussed above, the criterion of value must be assessed by reference to a "reasonable person" standard and not by community standards. *Pope v. Illinois*, 481 U.S. 497 (1987); *Anderson*, 322 N.C. 22; *Smith*, 89 N.C. App. 19; *Watson*, 88 N.C. App. 624; *State v. Roland*, 88 N.C. App. 19 (1987); *State v. Smith*, 87 N.C. App. 217 (1987).

4. The material as used is not protected or privileged under the U.S. or N.C. Constitutions. Note that possession of obscene material in one's own home is constitutionally protected. *Cinema I Video, Inc. v. Thornburg*, 83 N.C. App. 544 (1986); *Smith*, 89 N.C. App. 19.

Obscenity is judged with reference to ordinary adults, except that it is judged with reference to children or other especially susceptible audiences if its dissemination is designed for or directed toward children or such audiences. G.S. 14-190.1(d).

A witness's testimony describing the material alleged to be obscene was sufficient to sustain a conviction without introduction of the material itself. *State v. Mueller*, 184 N.C. App. 553, 564–67 (2007) (“[n]othing in section 14-190.1 requires the State to produce the precise material alleged to be obscene”).

Search warrant and criminal process. Violations of G.S. 14-190.1 through 14-190.5 are subject to G.S. 14-190.20, which provides that a search warrant or criminal process for these offenses may be issued only on the request of a prosecutor.

In 1985, the General Assembly repealed the statutory requirement that material be declared obscene in a civil adversary hearing before a person may be prosecuted for its dissemination. The repeal of that requirement has been upheld as constitutional, *Cinema I Video*, 83 N.C. App. 544; *Smith*, 87 N.C. App. 217, though a defendant has a constitutional right under the First and Fourteenth Amendments to a prompt, post-seizure adversary hearing on the obscenity of seized material pending trial. The burden is on the person seeking return of the material to request a hearing. *Cinema I Video*, 83 N.C. App. 544.

Constitutionality. The statute is not unconstitutionally vague or overbroad. *Id.*; *State v. Cinema Blue of Charlotte, Inc.*, 98 N.C. App. 628 (1990).

Multiple convictions and punishments. When a person disseminates several obscene items during a single transaction, only one offense is committed. *State v. Smith*, 323 N.C. 439 (1988).

Material contraband. G.S. 14-190.1(h) provides that obscene material disseminated, procured, or promoted in violation of the statute is contraband. The statute sets out no disposition procedure for contraband obscene material, and therefore a court order should be obtained to dispose of it.
